He also serves as the Director of the Corporate Governance Competence Centre at the Research Institute for International Management of the University of St.Gallen and is a lecturer for mergers and acquisitions, corporate law and corporate governance at the University of St.Gallen. Andreas Binder serves as a member of the core faculty of the University’s master programme “Strategy and International Management”, which between 2011 and 2022 has been ranked no. 1 in the Financial Times’ global ranking of master’s in management programmes for twelve years consecutively.

Andreas Binder is the co-editor of the comprehensive interdisciplinary work “Mergers & Acquisitions – Handbook for Strategists, Analysts, Consultants and Lawyers”, which was published in German in 2010 and revised and published again in 2016 by the Stuttgart-based publishing house Schäffer Poeschel. The revised third edition will be published in 2024.

In his capacity as chair and member of various boards of directors of industrial, commercial and financial companies, Andreas Binder has acquired extensive experience and expertise from a corporate perspective, co-orchestrated and supervised comprehensive change processes, led M&A transactions and became proficient in dealing with the diverse challenges as well as the advisory needs and expectations of members of the board of directors and executive management.

Since 2013, Andreas Binder has been a member of the Conference Board's European Council on Corporate Governance.
